SUPREME COURT JUSTICE #2

NARAL Pro-Choice Montana PAC is committed to protecting our state's constitutional right to privacy. That is why we are putting the Supreme Court race front and center in our electoral work. Supreme Court justices often have the biggest effect on reproductive healthcare access through the judicial system. Justices rule on choice-related cases ranging from parental consent for abortions to buffer zones to insurance coverage of contraceptives. In Montana, the final arbiter on these laws is the Supreme Court. We are working to ensure that we keep a Supreme Court that values freedom and privacy and that will protect the independence and objectivity of our courts.

Candidates who appear in our endorsement guide are certified to be pro-choice by the NARAL Pro-Choice Montana PAC. Candidates are chosen for endorsement based on their answers to a comprehensive questionnaire, their voting record, and/or personal interviews. The PAC does not endorse candidates for federal office in accordance with campaign finance laws. If a candidate is not listed here, it is either because they didn't return our questionnaire or follow through with an interview, because we were unable to identify a pro-choice candidate, or because the office they are seeking does not address reproductive choice issues.

- Access to **affordable birth control** and reproductive health care
- Access to emergency contraception to **prevent unintended pregnancies**
- Medically accurate, age-appropriate **sex education**
