



# 2005 Montana Legislative Voting Record on Choice

An analysis of votes made on legislation related to reproductive freedom and choice at the 2005 session

## 2005 Session at a Glance

\*We passed the first piece of pro-choice legislation in Montana history!

\*All attempts to restrict Montanans' reproductive freedoms were defeated.

\*NARAL Pro-Choice Montana Choice Action Network Activists sent over 11,000 letters to Montana lawmakers.

### House:

45 Reps had 100% pro-choice records.  
32 Reps had 0% pro-choice voting records.  
23 Reps had mixed records.

### Senate:

24 Senators had 100% pro-choice voting records.  
19 Senators had 0% pro-choice voting records.  
7 Senators had mixed records.

**Together, we have defeated every single anti-choice bill for the *third* consecutive Session!**

NARAL Pro-Choice Montana and NARAL Pro-Choice Montana Foundation are proud to release the 2005 Montana Legislative Voting Record on Choice for the 59th Congress.

As we look back on the 2005 session, the pro-choice community has many victories to celebrate. After successfully electing a pro-choice majority in the Senate and the first pro-choice governor in twenty years, NARAL Pro-Choice Montana was ready to work not only to defend reproductive rights, but to broaden our access to reproductive health care.

For the *first time in Montana history*, we were able to pass a truly pro-choice piece of legislation—the clinic safety or “bubble” bill. We also helped get new language inserted into Montana law allowing physicians' assistants to perform abortions and defeated *all six* attempts to restrict Montanans' reproductive freedoms.

Our actions also advanced the contraceptive coverage bill farther than it has ever gotten before, and we remain committed to gaining contraceptive coverage through other means.

Our Choice Action Network activists sent over 11,000 letters to elected officials in Montana. The only way we can continue to be effective in protecting women's rights is to maintain the grassroots pressure our members put on the state legislature to do the right thing. Our strength is in our numbers.

Anti-choice extremists say they oppose abortion, yet in the 2005 Session, they opposed safe, responsible birth control and access to family planning services for Montana women.



If these anti-choice legislators and fringe groups really wanted to prevent unwanted pregnancies and abortions, they would join us in supporting proven methods of preventing pregnancy such as allowing women to access safe, reliable information and birth control.

Anti-choice members of the House Business and Labor Committee stalled the Contraceptive Coverage bill, a bill that would have improved women's access to affordable birth control and helped decrease unintended pregnancy in Montana. Votes against this common sense bill starkly illustrate anti-choice lawmakers' opposition not only to a woman's right to choose, but also to measures that reduce unintended pregnancy and thus the need for abortion, help women enjoy healthy pregnancies, and give children a healthier start in life.

We must stand up for liberty and freedom, privacy and dignity, independence and self-determination. These are not only pro-family, pro-women values, these are Montana values.

NARAL Pro-Choice Montana believes in a culture of freedom and personal responsibility and the right of individuals to make decisions about reproduction instead of politicians or the government.



# Overview of 2005 Choice-Related Bills

## Explanation of Votes

### **SB 203-Require Insurance Companies to Cover Contraception, Sponsor Greg Lind (D-Missoula)**

This bill would have required insurance companies to cover contraception if they cover other prescription drugs. This bill was fair and cost-effective. Access to affordable contraception is central to women's autonomy and equality. This bill passed in the Senate, and stalled in the House Business and Labor Committee. A motion to blast the bill out of committee, which requires 60 votes, failed in the House by a vote of 52-48. A yes vote is a pro-choice vote.

### **HB 231-Fetal Homicide Act, Sponsor Penny Morgan (R-Billings)**

This bill's true intent was to undermine the right to privacy by giving separate legal rights to an embryo or fetus. Disguised as an anti-crime bill, this is part of a long-term strategy to undermine the legal tenets of *Roe v. Wade* and the right to choose. This bill was tabled in the House Judiciary committee. A motion to blast the bill from the committee failed in the House. A no vote is a pro-choice vote.

### **HB 324-Clinic Safety, Sponsor Robyn Driscoll (D-Billings)**

HB 324 protects patients from anti-choice harassment and violence by establishing a buffer zone around reproductive health clinics. The bill prevents protesters from coming within eight feet of people entering or exiting healthcare facilities within 36 feet of the facility, the average distance between Montana clinics' doors and the public sidewalk. This law strikes a reasonable and responsible balance between a patient's right to access health care and a protester's right to free speech. This bill passed and was signed into law on April 28th, 2005, the first pro-choice bill ever passed in Montana. A yes vote is a pro-choice vote.

### **HB 324, House Amendment 1, Sonju (R-Kalispell) to lower the fine to \$500**

This amendment passed. A no vote is a pro-choice vote.

### **HB 324, House Amendment 2, Lange (R-Billings) stated that local governments can't change the restrictions**

This amendment passed. A no vote is a pro-choice vote.

### **HB 324, House Amendment 3, Wagman (R-Livingston) to change the "buffer zone" from 8 ft to 4 ft**

This amendment failed. A no vote is a pro-choice vote.

### **HB 324, House Amendment 4, Wagman (R-Livingston) to lower the fine to \$100**

This amendment passed. A no vote is a pro-choice vote.

### **HB 324 Senate Amendment 1, Grimes (R-Clancy) to allow parents to approach minors entering clinics**

This amendment failed. A no vote is a pro-choice vote.

### **HB 324, Senate Amendment 2, O'Neil (R-Columbia Falls) to narrow the focus of the bill so that it wouldn't be a crime to obstruct clinic entrances**

This amendment failed. A no vote is a pro-choice vote.

### **HB 730 Revise Parental Notification Law, Sponsor Mike Lange, (R-Billings)**

HB 730 sought to revise Montana's existing unconstitutional parental notification law. Parental consent laws endanger young women who cannot turn to a parent when faced with an unintended pregnancy because of an abusive home or for any other reasons that could force them to take matters into their own hands. This bill passed in the House and was tabled in the Senate Judiciary Committee. A motion to blast this bill out of committee failed. A no vote is a pro-choice vote.

### **HB 737 Revise Laws Governing Physician Assistants, House Amendment, Jones, W (R-Kalispell)**

This amendment sought to reinstate unconstitutional language barring Physician's Assistants from performing abortions. This amendment failed. A no vote is a pro-choice vote.

### **HB 737 Revise Laws Governing Physician Assistants, Senate Amendment, Ellingson (D-Missoula)**

This amendment inserted language stating a P.A. may perform an abortion. This amendment passed. A yes vote is a pro-choice vote.

### HB 617-Require Death Certificates for Abortions, Sponsor Roger Koopman (R-Bozeman)

The intention of this bill seemed to be to shame and demean women who exercise their right to choose. The bill would have required women seeking an abortion to disclose the name of the father and give the father (and her children, parents and others) the right to access the death certificate. This bill was heard in the House Judiciary Committee and defeated on a 10-8 vote. A no vote is a pro-choice vote.

### HB 730-Revise Parental Consent Law, Sponsor Michael Lange (R-Billings)

Montana courts have already struck down a parental consent law, making HB 730 unconstitutional. Parental consent laws endanger young women who cannot turn to a parent when faced with an unintended pregnancy because of an abusive home or for any other reasons that could force them to take matters into their own hands. This bill was tabled in committee. A no vote is a pro-choice vote.

### SB 203, Amendment to add a "Refusal Clause" to Require Insurance Companies to Cover Contraception

This amendment was so broad it would have allowed anyone to state a "moral opposition" to contraceptives and therefore opt out of providing coverage. This amendment would have essentially gutted the bill. The amendment was added to the bill before it was eventually tabled by the House Business and Labor Committee. A no vote is a pro-choice vote.

### SB 473-Exclude certain minors receiving abortions from liability caps, Sponsor Jerry O'Neil (R-Columbia Falls)

This bill was intended to send a message that abortions are unsafe by exempting them from medical malpractice settlement limits. In reality, legal abortion is one of the safest and most common medical procedures available today. This bill was tabled in the Senate Judiciary Committee. A no vote is a pro-choice vote.
